## EXECUTIVE SUMMARY

On 13 May 2019 Council resolved to give Statewide public notice of the *City of Kalgoorlie-Boulder Activities on Thoroughfares and Trading in Thoroughfares and Public Places Amendment Local Law 2019* and the *City of Kalgoorlie-Boulder Local Government Property Amendment Local Law 2019* (together referred to as “**the 2019 Amendment Local Laws**”) and furnish a copy of the 2019 Amendment Local Laws and applicable notices upon the Minister.

Statewide public notice was effected on 22 May 2019 and the period for submissions concluded on 3 July 2019. No public submissions were received with respect to the 2019 Amendment Local Laws.

The Department of Local Government, Sport and Cultural Industries has provided its comments to the City, recommended minor grammar and formatting changes. The City has made the proposed minor amendments, with the 2019 Amendment Local Laws not changing in substance.

Council endorsement is sought to adopt the 2019 Amendment Local Laws pursuant to section 3.12 of the Act.

## BUDGET IMPLICATIONS

Costs associated with the advertising and gazettal of the amendment local law will come from the local laws review budget. There are sufficient funds in the local laws review budget for this purpose. Implementing the amendment local law should not have any other financial implications for the City.

## REPORT

The 2018 Amendment Local Laws were disallowed effective on and from 31 October 2018.

The City has considered the recommendations of the Committee and sought independent legal advice before commencing the process to make the local laws amendments as a 2019 amendment. The 2019 Amendment Local Laws have been drafted in accordance with that advice and considering the recommendations by the Committee.

*City of Kalgoorlie-Boulder Activities on Thoroughfares and Trading in Thoroughfares and Public Places Local Law 2000*

The **purpose** of the local law is to amend the *City of Kalgoorlie-Boulder Activities on Thoroughfares and Trading in Thoroughfares and Public Places Local Law 2000*.

The **effect** of the local law is to amend the framework for the control of specific activities and certain antisocial behaviour on thoroughfares and public places and will provide authority to enforce the laws and administer fines.

In summarising, the following amendments further to the proposed and subsequently disallowed *City of Kalgoorlie-Boulder Activities on Thoroughfares and Trading in Thoroughfares and Public Places Amendment Local Law 2018* are proposed as follows:

### 1. **Clause 2.1 amended**

The Committee recommended the City reconsider the use of the word annoy. This has been replaced with the word harass, the ordinary meaning of which is “1. to trouble by repeated attacks, incursions, etc., as in war or hostilities; harry; raid. 2. to disturb persistently; torment.”. It is intended this will address concerns of “annoy” encompassing minimally disruptive behaviour.

References to “indecent act” at 2.1 have been removed based on the Committee’s view such behaviour should only be regulated by an Act of Parliament. The reference to “offensive act” is otherwise retained, having not been the subject of comment by the Committee.

The Committee considered that proposed 2.2(1)(n) contained matter not appropriate for subsidiary legislation as begging in streets and other public places ‘is a matter of broad social significance’ and prohibiting begging involves a ‘fundamental change to existing policy’ and a ‘fundamental change in the law, intended to alter and redefine rights, obligations and liabilities’. In consideration of this comment, this provision has been removed.

### 2. **Clause 2.2 amended**

The Committee addressed issues with the 2018 Amendment, as such the references to “placing of furniture” have been reworded so as to refer more generally to the placing of any thing in or on a public place so as to cause nuisance or obstruction.

### 3. **Schedule 1**

Schedule 1 has been amended as required to encompass the above amendments.

### *City of Kalgoorlie-Boulder Local Government Property Local Law 2010*

The **purpose** of the local law is to amend the *City of Kalgoorlie-Boulder Local Government Property Local Law 2010*

The **effect** of the local law is to amend the requirements with which any person using or being on all local government property within the district, must comply.

In summarising, the following amendments further to the proposed and subsequently disallowed *City of Kalgoorlie-Boulder Local Government Property Amendment Local Law 2018* are proposed as follows:

### **1. Clause 4.1 amended**

References to the word annoy have been replaced with the word harass for the same reasons identified above for the Thoroughfares and Public Places Amendment Local Law.

References to “indecent act” at 2.1 have been removed based on the Committee’s view such behaviour should only be regulated by an Act of Parliament. The reference to “offensive act” is otherwise retained, having not been the subject of comment by the Committee.

The Committee’s comments in relation to soliciting money were again raised in the content of the Property Amendment Local Law. Accordingly references have been removed.

### **2. Other Amendments**

A definition of “nuisance” has been included, with the addition of a clause at 3.13(1)(t) prohibiting the creation of a nuisance on Local Government property without a permit. Clause 3.13(1)(u) has been reworded so as to refer more generally to the placement of any thing so as to cause a nuisance or obstruction.

The City has provided the Minister with a copy of the 2019 Amendment Local Laws in accordance with the Council resolution of 13 May 2019. The minor grammar and formatting recommendations by the Department have been adopted. These changes are not substantive in nature.

The Statewide public notice period concluded on 3 July 2019 and no submissions were received.

Accordingly, it is recommended Council endorse the adoption of the 2019 Amendment Local Laws.

### **STATUTORY IMPLICATIONS**

The City must comply with the procedure for amending Local Laws as prescribed in s3.12 of the *Local Government Act 1995*.

This information is available from the Western Australian Electoral Commission (“**WAEC**”) and the Department of Local Government, Sport and Cultural Industries (“**the Department**”).

The City of Kalgoorlie-Boulder 2019 Local Government Ordinary Election will be held on Saturday 19 October 2019. The election will be for six (6) Councillor Positions and for the position of Mayor.

The budget provisions for the 2019 Local Government Ordinary Elections were made in the 2019/2020 Budget.

### REPORT

The purpose of this report is to advise Council and the Electors of key dates for the 2019 Local Government Ordinary Elections. This information is available to the public from the WAEC and the Department.

In Western Australia, Councillors are elected for a term of four years. Elections are held every two years for half the Council. Mayoral elections are held every four years and there will be a Mayoral election this year.

The 2019 election will be for six (6) Councillor Positions and for the position of Mayor.

The City has again contracted the WAEC to run the postal election following the resolution by Council on 12 November 2018. The Returning Officer has been appointed by the WAEC and the City will receive notification of the contact details of the appointed officer by way of the call for nominations advertisement on 28 August 2019.

2019 Key Dates:

*14 August 2019: Statewide public notice*

The WAEC Statewide public notice of the date and time of close of enrolments will commence on 14 August 2019. Notices will be published in the West Australian Newspaper, the Kalgoorlie Miner and displayed on City notice boards.

*30 August 2019: Close of roll*

The roll closes at 5:00pm on 30 August 2019. All enrolments for voters not currently enrolled must be lodged with the Chief Executive Officer by 5:00pm on Friday 30 August 2019.

*5 September 2019: Nominations will open*

First day for candidates to lodge completed nomination paper, in the prescribed form, with the Returning Officer. Candidates are required to complete the compulsory Local Government Candidate Induction facilitated by the Department prior to nominating.

*12 September 2019: Nominations will close*

Nominations will close at 4:00pm on the 37<sup>th</sup> day before the election. Candidates will be asked to declare they have completed the online induction when filling out the nomination form therefore should leave enough time to complete the induction before nominations close.

*18 September 2019: Statewide public notice*

The Returning Officer is to give Statewide public notice of the election.

*20 September 2019: Election packages lodgement*

The WAEC lodgement of election packages with Australia Post commences today. The City has nominated to utilise the priority post service for returned election packages.

*19 October 2019: Election Day*

Polls close at 6:00pm on 19 October 2019.

*24 October 2019: Election Result Advertisement*

The election result advertisement will be published on or about this date.

Following the declaration of the result, the Returning Officer will comply with the reporting requirements in accordance with the *Local Government Act 1995* and the *Local Government (Elections) Regulations 1997*.

**EXECUTIVE SUMMARY**

Cardno Spectrum Surveys, on behalf of the landowner of Lot 21 (32A) Campbell Street, Lamington, is seeking Council's support to excise and amalgamate a portion of Reserve 35222 with Lot 21 (32A) Campbell Street, Lamington. The change is requested by the landowner to rectify longstanding building and fence line encroachments into the Reserve.

The City was granted a management order over Crown Reserve 35222 in October 2001 for the purpose of "Drain". The proposed excision does not impact upon the

---

functionality of the Reserve. Additionally, there would be no change to the outward appearance of the Reserve as a result of the proposed excision.

The landowner has indemnified the City of Kalgoorlie-Boulder from any costs associated with this process.

Council is requested to support the proposal to seek the Minister's approval for the excision and subsequent amalgamation of the subject portion of Reserve 35222. Further land dealings and terms of land purchase are negotiated between the landowner and the State.

### **REPORT**

Acting for the landowner Jackson Hughes, Cardno Spectrum Survey is seeking Council's support to request the Minister's approval for the excision and amalgamation of a portion of Reserve 35222 into Lot 21 (32A) Campbell Street, Lamington.

Freehold Lot 21 (32A) Campbell Street, Lamington has structures encroaching approximately 207m<sup>2</sup> into neighbouring Reserve 35222. As illustrated in Figure 1, the boundary fence and portions of both the dwelling and outbuilding protrude into the Reserve. The applicant has estimated that the encroachments have existed for approximately 50 years.

Crown Reserve 35222 is zoned 'General Residential' R12.5 and, in addition to the use of the Lot as a drain way, it is also used as a garden (Davidson Garden). The proposed excision will not impact upon the existing location of the drain running through Reserve 35222, nor will there be any impact on the use or appearance of the Reserve as Davidson Garden. The proposal would not impact upon the location of existing utilities or services and no easement or encumbrances would be required as part of the excision and amalgamation process.

The landowner has indemnified the City against all costs associated with the excision and subsequent amalgamation of the land.

The excision and amalgamation of the portion of the Reserve will bring to conclusion an outstanding encroachment issue. Council's support for the excision and



amalgamation will enable the landowner to proceed with purchasing the land from the State.

### EXECUTIVE SUMMARY

The Building Commission has released the 2019/2020 statutory fees and charges to be applied to building applications and associated permits. The new fees were not published at the time of adoption of the fee schedule by Council on 13 May 2019.

The new schedule of building fees reflect an increase of 7% as a result of a review conducted by the Department of Mines, Industry, Regulation and Safety. The fees are prescribed by State regulation and apply uniformly across local government.

It is recommended the Council adopt the revised fees and give notice in accordance with the requirements of the Act.

### COMMUNITY STRATEGIC PLAN LINKS

This report links to the Strategic Community Plan through the Community's Guiding Principles to plan for regulated sustainable land use and development.

### BUDGET IMPLICATIONS

The fee increases will generate additional revenue in the order of \$5,000.

## REPORT

The *Building Act 2011* provides powers to the Building Commission to set statutory fees for Local Governments for building applications and associated permits.

The attached table breaks down the building fees as prescribed by the *Building Regulations 2012*. The annual fee increases are the result of a review undertaken by the Department of Mines, Industry Regulation and Safety at the request of the Parliament's Joint Standing Committee on Delegated Legislation. Building fees as a result of this review, increased by 7% for the 2019/20 year. This increase affects all of the individual charge categories for the services provided by Building Services.

It is recommended that the City's schedule of fees and charges be amended to align with the prescribed charge rates.

### **STATUTORY IMPLICATIONS**

Section 6.19 of the *Local Government Act 1995* requires local government to give notice of a fee or charge for not less than 7-days for any goods or service it provides.
