Background:

Notice was given by the GVROC Executive Officer on 10 January 2020, that at the GVROC Meeting to be held on Friday 31 January 2020 an election would be held for the positions of Chair and Deputy Chair of the GVROC. As the GVROC and the Goldfields Esperance Country Zone of WALGA (GECZ) operate as a single entity these elections are also in respect to the GECZ, i.e. for the positions of WALGA State Council Representative and WALGA Deputy State Council Representative. The term of appointment is for a two-year period ending no later than December 2021.

Nominations for the positions of Chair/ WALGA State Council Representative and Deputy Chair / WALGA Deputy State Council Representative will be announced at the meeting as received through the call for nominations sent on 10 January 2020, which closed at 4pm on 24 January 2020. The election and vote if required will be conducted having regard to the general principles and procedures of the *Local Government Act 1995*.

If only one nomination is received for a position, an election vote will not be required. If multiple nominations are received the procedure for the conduct of this election vote will be as follows:

- Prior to the ballot, nominees (should there be more than one nomination) for each position will be extended the opportunity to provide a two-minute election bid to delegates. Note a nominee must be a Councilor nominated as a Council delegate to the GECZ;
- The ballot will be conducted as a secret ballot;
- Each voting delegate to the GVROC will be entitled to cast one (1) vote in the ballot process, with the "first past the post" method of election being used; and
- The candidate with the greater number of votes will be elected.

In the event of a tie between two candidates a second ballot will be conducted immediately. Should the second ballot also be a tie, lots will be drawn, and the name drawn first will be the successful candidate.

Officer Comment:

Mr Andrew Mann, GVROC Executive Officer announced as the returning officer, at the close of nominations at 4pm on Friday 24 January 2020 for the positions of GVROC Chair / WALGA State Council Representative and GVROC Deputy / Deputy WALGA State Council Representatives, that one nomination for GVROC Chair / WALGA State Council Representative and two nominations for the GVROC Deputy / Deputy WALGA State Council Representative were received as follows:

GVROC Chair / WALGA State Council Representative

Cr Malcolm Cullen – Shire of Coolgardie, Shire President

GVROC Deputy / Deputy WALGA State Council Representative

Cr John Bowler – City Kalgoorlie Boulder, Mayor

Cr Laurene Bonza – Shire of Dundas, Shire President

As there was only one nomination for the Chair of GVROC and WALGA State Council Representative, Cr Malcolm Cullen, no election or vote was required for this position at the GVROC meeting with Malcolm declared by the GVROC to undertake these roles for the next two years until the end of December 2021.

Given there are two nominations for the GVROC Deputy / Deputy WALGA State Council Representative an election and voting process was held as per the above process described in the background section at the GVROC meeting on Friday 31 January 2020 and in accordance with the principles and procedures of the *Local Government Act 1995*.

The outcome of the voting process was 12 votes to Cr Laurene Bonza – Shire of Dundas, Shire President and 6 votes to Cr John Bowler – City Kalgoorlie Boulder, Mayor. On the basis of this vote the GVROC then declared Cr Laurene Bonza to undertake the Deputy roles for the next two years until the end of December 2021.

Cr John Bowler was thanked for his service to the Deputy role for the last two years.

9. GVROC - LAW AND ORDER

City of Kalgoorlie Boulder (CKB), Mayor Bowler provided a verbal update for the law an order item following the meeting between the Shire of Ngaanyatjarraku President, Cr Damian McLean and CEO Mr Kevin Hannagan, Mayor Bowler with the Federal Minister for Aboriginal Affairs, Hon Ken Wyatt, on the 28 January 2020 to further discuss the issues that were raised at the Canberra visit by the CKB in 2019.

Mayor Bowler advised that the Ngaanyatjarraku people would like the reintroduction of the CDEP as this was proven to be effective when it was implemented last time and that the Cashless Debit Card does not have the same support due to a number of reasons e.g. telecommunications is a huge issue and this causes issues with the ability for cards to be utilised and accepted.

Minister Wyatt has taken this on board and will consider it with his Federal counterparts in Cabinet.

It was also noted that Hon Jacqui Lambie also recently visited several of the GVROC local governments cashless debit card sites in the region to discuss its effectiveness, before the Senate is expected to vote on the trial's extension next month, which could extend the current trial sites past 2021 (refer to Item 12.11 in minutes)

Background:

The City of Kalgoorlie Boulder (CKB) is the Designated Area Representative (DAR) for the DAMA in the Goldfields. The CKB has established the systems and processes required to manage the DAMA and it launched the Goldfields DAMA website on 24 June 2019 - www.goldfieldsdama.com.

The CKB started accepting applications on 1 July 2019 and will assess applications within 15 working days. Around 80 people attended the 1st Goldfields DAMA information session in April 2019 and around 50 people attended the 2nd Goldfields DAMA information session & website launch – June 2019.

Year 1 - Key Elements:

- Currently restricted to 72 approved occupations
- Ceilings of 500 approved nominations for TSS/ENS visas
- English language concessions for 28 occupations
- Salary concessions for 4 occupations
- Age concessions – an age limit of 50 years old for a PR pathway through ENS (Subclass 186) visa (note: cannot turned 50 at time of PR nomination)
- Provides a pathway to permanent residency (for skill level 1 to 4 occupations)

To date the CKB has:

- Received over 365 DAMA queries.
- The Goldfields DAR has endorsed 17 businesses, which includes 40 TSS/ENS nominations. By the end of February 2020, there may be up to 50 TSS/ENS nominations endorsed by the Goldfields DAR. See the below table for the occupation breakdown:

- 27 October 2019 to 24 January 2020, the Goldfields DAMA Workforce Survey was promoted, and businesses are encouraged to fill the survey, seeking additional information and data of what other occupations are needed for the roll out of the Year 2 Goldfields DAMA program.
- Currently, the Goldfields DAR is preparing the negotiation stage of the Goldfields DAMA year 2 program by drafting a deed of variation and annual report to Minister Alan Tudge.

- The type of occupations may be added in the second-year program includes Café or Restaurant Manager, Cook, Greenkeeper, ICT Customer Support Officer, Rope Access Technician, Hairdressers and many more. The negotiation will be signed and finalised in late-March 2020.

Officers Comments

Since implementing the DAMA, migrants have expressed greater interest in relocation to Goldfields through the DAMA and other pathways. On 16 November 2019, the Kalgoorlie Miner wrote an article detailing the interest migrants from the United Kingdom in relocating to Kalgoorlie-Boulder but have had trouble in finding an employer to sponsor them, despite being highly qualified and experienced in their professions. The article highlighted the plight of one British couple who expressed interests in relocating to Kalgoorlie-Boulder but could not find anyone to sponsor him. Since the publication of the article, DWE Electrical has approached EasyMigrate to get in contact with the man in the article and elected to sponsor and hire him.

Regional Councils from around Australia have also experienced interests in implementing the DAMA in their jurisdiction given the direct and indirect benefit having the DAMA can bring to their region.

Several agencies and services have responded to the interest and opportunity as a result of the additional interest in Kalgoorlie-Boulder generated by the DAMA. Central Regional TAFE is also planning to increase its offering to International Students by providing courses for migrants to study English and improve their literacy in the language.

Agenda for the next 12 months

Collectively the Goldfields DAMA Partners will continue to liaise with businesses to help alleviate labour shortages through the DAMA and other avenues. Increased interests in the DAMA will be achieved through speaking at key events, facilitating workshops, and promoting success stories of the DAMA program. The success stories will highlight the uniqueness of the Goldfields and the warm, inclusive community that has embraced the migrants. Collaborative effort from all DAMA partners will achieve the greater promotion of the DAMA, and the Goldfields region as a whole as a destination to live, work and invest in.

Background:

During the last few GVROC meetings the issue of dealing with the increased number of Feral Herbivores (including camels) has been discussed. While the current process has been to undertake planned culls, the GVROC is looking at alternative opportunities that could be progressed that actually turn this problem into a solution and a potential new industry for the region. It is estimated that the number of camels is projected to double every 8 to 10 years at a pace of approximately 10% a year, highlighting this growing problem.

Comment:

The GVROC Chair and Executive Officer continue to work with the GEDC, GNRBA, DPIRD and industry stakeholders to further explore areas of opportunity to deal with the problem of the Feral Herbivores (including camels).

The following provides a brief update on progress to date:

A MOU has now been signed between the GVROC and the GNRBA.

The GEDC has developed a short draft proposal outlining the background and proposed undertaking for the Camel Meat Meal Fertilizer Pilot, mentioned at the last GVROC meeting (see Attachment X). Please note that the GEDC does not intend to be the project owner for this pilot, and this will need to be determined as part of the ongoing feasibility work.

The GEDC is discussing with DPIRD regarding the Camel Meat Meal Fertilizer Pilot proposal and investigating potential opportunities for support through some of the Department's Agribusiness programs. The GEDC will continue to update GVROC on these matters which are the responsibility of the DPIRD.

The GVROC Chair and Executive Officer met with Nat James (Southern Star Holdings) and Gilad Berman regarding their proposal to establishing a Camel Hub Operation (Producing Camel Milk, Camel Meat and Camel Pet Meat Meal as a solution to the feral camel issues in the region. This has resulted in the presentation being delivered at this meeting.

Also, of note is a recent article in the Australian Newspaper on 6 January 2020 also highlighted that the South Australian Government in conjunction with leaders of the Anangu Pitjantjatjara Yankunytjatjara (APY) Lands had ordered a camel cull operation of 10,000 head of camel in that State. As of 18 January 2020, it had been reported that over 5,000 camels have been culled.

Similarly, the CEO of the Shire of Ngaanyatjarraku has advised of the work being done in its region by the Ngaanyatjarra Council Aboriginal Corporation (NCAC) and the Ngaanyatjarra Camel Company (NCC), which was established as a business by the NCAC to muster and sell camels. Its work has vastly reduced camel numbers and damage compared to previous droughts. The NCC have gone down the road of commercial mustering rather than culling because it creates ongoing employment for its people. The NCC has removed over 40,000 camels from the region and paid \$2.6m in Anangu Wages, since its commencement in 2012. The NCC removed 6,580 camels from the region in the 2018/2019 financial year. They worked a lot with APY Traditional owners that had a very large influx of camels that needed to be removed to prevent damage to cattle and community infrastructure. Skill sharing between the NCC and the Ranger teams has also been a fabulous outcome. The NCC has done excellent work and is the one of the only small business to set up in the Shire of Ngaanyatjarraku. The NCC do not support culling but the expansion of its mustering operation and would be interested to discuss options with GVROC and any of the interested parties looking at other options for the camels to culling.

Background:

On 15 November 2019 at the GVROC meeting a motion was adopted to establish a Drought Relief Committee subject to terms of reference being established and endorsed out of session by the GVROC.

Currently the Western Australia State Government is only committed to a “Dry Season” for the region, under the definitions of its Drought Policy. This is currently severely hampering local rangelands pastoral lease holders, farming land holders, associated industries and local governments in the region ability to access Federal Government Drought relief funding. Western Australia is the only State or Territory in Australia that does not have a drought declared area making it ineligible to receive funding, despite many areas currently being drought affected.

The other States have implemented processes which have already displayed that by having a coordinated response to drought, it can help support the retention of families on farms, and assist with employment generated through Infrastructure Programs for our region that could keep people on farms, and associated support industries in the regions and create jobs.

Therefore, the purpose of establishing a GVROC Drought Relief Committee is to assist in getting Western Australian rangelands drought declared by the Western Australian Government to assist our pastoral lease holders that are in drought.

The GVROC Drought Relief Committee will be tasked to determine the most effective governance process for becoming drought declared and to lobby and seek assistance for our Rangelands Pastoral Lease holders, farming land holders and associated industries sustainability into the future in the areas affected by the drought.

The Drought Relief Committee can also lobby State Government that pastoral land on mining leases should be managed under one Legislation, this will assist with the Feral Pest and Weeds issues and make this a even playing field and more competitive, hopefully then keeping more families, even on mining leases, as there are many cases that the two can co-exist, if managed properly.

Once drought declared, we should have a drought policy that is based on the concept of self-reliance, with a clear understanding drought is not caused by our farmers but by weather patterns. Primary producers should therefore adopt risk management strategies to minimise the impact of drought on their enterprises. However, it is recognised that prolonged and severe events may be beyond the ability of many producers to cope with financially and physically. If a property has been individually drought declared or is within a drought declared area, the property owner should be able to apply for drought assistance, including the Drought Relief Assistance.

This will provide subsidies on the transport of fodder and water for livestock during drought and returning from agistment and restocking in the recovery period, as well as the Emergency Water Infrastructure Rebate to assist primary producers provide urgently needed water for animal welfare needs, from State Government.

It is the GVROC's view that there is a strong need to establish a Drought Relief Committee within GVROC to assist in the development of a clear plan and hierarchy for the future to address this issue. The Committee will work in cooperation with Federal and State Governments to ensure the future for primary producers and associated industries in the Region.

Officer Comment:

The draft Drought Relief Committee ToR were circulated out of session to the GVROC for comment in December 2019/January 2020. Several suggestions and comments have now been incorporated into the final version, which is attached to the agenda papers. Overall, all GVROC Councils supported the establishment of the Drought Relief Committee based on these revised and final ToR.

The Drought Relief Committee will be a sub-committee of the GVROC coordinated by the GVROC Councils and will include the following representatives:

1. Chair of the GVROC
2. Three nominated delegates from GVROC via EOI; and
3. Up to three nominated GVROC LGA CEOs via EOI.

It is now requested that the GVROC delegates undertake an EOI process during this agenda item to formalise its representatives.

It should also be noted that since the last GVROC meeting, there was a visit to Kalgoorlie in late November 2019 from the Federal Minister LittleProud to meet and discuss the drought situation in Western Australia with various Local Governments and potential assistance measures that may be available. During the meeting Minister LittleProud promised the fast tracking of various measures to allow assistance funding to flow through to WA Local Governments early in the New Year.

On 19 December 2019 the State Government declared a water deficiency for the Grass Patch area in the Shire of Esperance.

The CEO for Shire of Dundas, Peter Fitchat, has looked at the current assistance measures and tried to apply for funding in January 2020, only to be told that the Shire of Dundas is not an eligible local government. It seems that nothing has progressed from the Federal Government side, following Minister LittleProud's promise to look at getting WA Local Governments assistance, however it is understood that the Federal Department responsible is reviewing its eligibility criteria but has not given a timeframe on when this may be completed.

This will be an area for the Drought Committee to focus its attention on when formed.

However, Cr Susie Williams has resigned from the CKB Council mid-last year and as such the GVROC has not had representation at meetings since that time.

Due to this situation the Department of Fire and Emergency Services (DFES) that manage the DEMC has formally requested to the GVROC Executive Officer that the GVROC nominate a new representative and proxy delegate to the DEMC.

The overarching role of the DEMC is to build resilience in communities through encouraging the prevention of and planning for high risk emergencies within the District in order to create safer, sustainable communities.

Currently the Goldfields Esperance DEMC's role includes;

- Assessing District Risk and assisting in the coordination of agencies to plan for these risks, i.e. the Rail response plan for the area of rail East of Kalgoorlie. Lack of medical services along the Eyre highway and contingencies around this. Development of district level remote response plans for all hazards.
- Ensuring that Local Governments and Local EM Committees (LEMCs) within the region are engaged in EM with a functional LEMC and are developing Local EM arrangements as per legislation.
- Development of inter-agency relationships at the district level which can be very beneficial in a major event, particularly in regard to the function of an Operational Area Support Group.
- Attendance at regional level HMA exercises that tests inter agency operability and the role community plays in these events.

Officer Comment:

DFES would ask that the nominated GVROC delegate would be able to attend regularly or provide a proxy. It is expected that they will represent the GVROC in their discussions, so may need to seek clarifications from other GVROC members to answer issues or participate in discussions that will be outlined in the agenda. This can also be an excellent forum for GVROC to raise district level concerns in regard to Emergency Management matters.

Background:

The recent bushfires centred around Norseman comprised of nine (9) fires as detailed below. All of these fires were started by lightning strikes during the period 16 December 2019 to 1 January 2020. DFES assumed control of the nine (9) bushfires within the Norseman Bushfire Complex under s. 13 of the Bush Fires Act 1954 on 31 December 2019. The Complex of fires was declared a Level 3 Incident at that time. The incident was downgraded to Level 1 on 18 January 2020 and the All Clear was issued on 19 January 2020. As at 20 January 2020 the total area burnt was approximately 546,432 hectares.

- Norseman West (175,164 ha) #
- Balladonia (158,000 ha) #
- Peak Charles (32,579 ha)
- Londonderry (12,044 ha)
- Dundas NR 1&2 (109,121 ha) #
- Caves Rock (271 ha)
- Wylie Scarp (58,974 ha) #
- Bedonia (279 ha) #

Fires within the Shire of Dundas.

The fires were contained to Unallocated Crown Land (UCL), Dundas Nature Reserve (DBCAs), Scahill Timber Reserve (DBCAs), Peak Charles Nature Reserve (DCBA) and a small portion of the south east corner of Balladonia Pastoral Station.

The fires threatened or directly impacted a number of roads including the Eyre Highway (Balladonia), the Coolgardie-Esperance Highway (Norseman West), the Hyden-Norseman Road and Mort Harslett Drive (Norseman West), the Lake King-Norseman Road (Peak Charles), Balladonia-Parmango Road and Zanthus Road, resulting in protracted road closures. A number of local roads were also closed as a result of these fires. This resulted in significant disruption to local, regional and interstate transport.

Despite the size and severity of the fires there has been no loss of human life, no serious injuries to firefighters or members of the public and limited physical damage to infrastructure and other community values.

However, as was found out through this experience and also highlighted after the tragic 2015 bushfires in Esperance and subsequent Coronial Inquest into the four deaths from those fires and the coroners recommendations (note to date most of these recommendations have not been actioned by the State) https://www.coronerscourt.wa.gov.au/Inquest_into_the_deaths_of_kym_brett_curnow_thomas_leslie_butcher_julie_kohrs_lichte_and_anna_sushchova_winterer.aspx, there is an urgent need to establish a detailed bushfire mitigation strategy for the region that can be presented by GVROC to the State and Federal Governments, outlining what the region would like to see changed and actioned to alleviate the impact on any future bushfire events.

When visiting the bushfire zone, Minister for Emergency Services, Fran Logan MLA, advised that the State Government would allocate funding towards the development of bushfire mitigation strategies and has provided a list of potential consultants that could be used. The process for accessing this assistance needs to be followed up to ensure that it can assist the GVROC in developing its Bushfire Mitigation Strategy for the Region.

Officers Comment:

The Shire of Dundas would like to get Political support to be more proactive in the approach to National and Regional Bush Fire Mitigation, noting the impact on larger and more populated areas is not the same for less populated areas, and the current disregard to small resource communities directly impacted by the following Acts and Trigger Points:

- Mining Act 1978,
- Bush Fires Act 1954,
- Category C Trigger point for small communities to be revised as the required trigger point of \$240,000.00 is over 10% of the Shire of Dundas's total revenue raised per financial year, compared to other areas like City of Kalgoorlie Boulder it would only be 0.2% of their Budget.
- Potential job opportunities directly linked to more sustainable management of the Woodlands and our Coastline.
- Local Government has to be resourced by Federal and State Government to be able to cope with large-scale emergency situations.

There is no State or Federal Act or Policy in place to assist a small resource community that is dealing with the financial burden of a bushfire and the expected management of the land, especially when it has a declining population and rates base. The Shire of Dundas advise it would need to increase its rates by 300% to continue to meet this need. Political pressure is required to address this issue and making the playing field more even especially looking at what the region is contributing to General Revenue, State and Federal Government, when setting trigger points.

The Shire of Esperance currently has a good working relationship with DFES, following on from Esperance Fires in 2015. It is currently working with them in a number of areas including:

- Undertaking a fuel load assessment report for the Esperance region
- Starting a pilot trial to test specific tyres on bush fighting vehicles as a result of the GVROC item raised at its meeting on 15 November 2019 and at the WALGA State Council meeting 4 December 2019.

However, the Shire would also like to see a detailed Bushfire Mitigation Strategy developed for the region and that this is recognised and actioned by the State and Federal Governments. Of particular relevance for the Bushfire Mitigation Strategy would be these recommendations from the Coroner Inquest into the November 2015 Esperance Fires, which relate to additional mitigation measures:

Recommendation 4

I recommend that the State Government give consideration to giving a higher drafting priority to the Consolidated Emergency Services Act.

Recommendation 7

I recommend that the South-East Fire Working Group's final plan for a long-term fire mitigation strategy be fully supported and funded by DFES and the State Government. I suggest that at a minimum, the funding should cover a period of ten years to allow for the creation of firebreaks and strategic fire exit tracks on the vast area of UCL in the Esperance region, with a view to then formalising ongoing funding for maintenance after that time on a long-term basis.

Recommendation 8

I also recommend that consideration be given to reviewing the Memorandum of Understanding between DPaW and the Shire and, as part of that process, the MOU should include a more streamlined procedure to ensure that the best balance can be met between ensuring that cognisance is taken of rare flora and fauna and areas of cultural significance on the interface with farms and UCL, but which permits farmers to undertake mitigation works expeditiously to ensure fire risk is reduced on the borders.

These recommendations can be expanded to the whole of the GVROC region for the Bushfire Mitigation Strategy.

The Federal Government recently also announced a range of Bushfire related funding, much of which Western Australia currently looks like being excluded, because of the current State Government's regulations, trigger points and classifications for disaster. These need to be reviewed and assessed in the context of the Bushfire Mitigation Strategy to ensure that the State and the GVROC LGAs are not disadvantaged to the rest of the Nation.

The Prime Minister also announced the formation of the National Bushfire Recovery Agency along with a new national bushfire recovery fund, with an initial \$2 billion commitment. (Link to the announcement: <https://www.pm.gov.au/media/national-bushfire-recovery-agency>). The RDA network has been asked to provide input into these programs as they are designed and implemented and RDAGE are seeking input from the GVROC. A GVROC Bushfire Mitigation Strategy could provide input into that process.

Additionally, the Federal Government House of Representatives Committee, under the request of the Minister for Water Resources, Drought, Rural Finance, Natural Disaster and Emergency Management, the Hon David Littleproud MP, resolved on 5 December 2019 to conduct an inquiry into the efficacy of past and current vegetation and land management policy, practice and legislation and their effect on the intensity and frequency of bushfires and subsequent risk to property, life and the environment (Refer to the following link <https://www.aph.gov.au/vegetationandlandmanagement>). Submissions into the inquiry close on 31 March 2020 and the Shire of Dundas is looking to put in a submission but would also do this as a joint GVROC submission, should the GVROC agree to submit as a collective group.

On 14th January 2019 a Local Government Bushfire meeting was also held with City of Kalgoorlie Boulder, Shire of Dundas and Shire of Coolgardie, organised by Kyran O'Donnell MLA and also attended by State Opposition Leader Liza Harvey to discuss the impact of the Norseman Complex Bushfires that led to the closure of the main entry point into the Eastern States – the Eyre Highway and the Coolgardie-Esperance Highway closure, leaving hundreds of travellers both from Western and Eastern states stranded across the borders for days.

The outcome from this meeting was a number of recommendations that should be considered in the development of a Bushfire Mitigation Strategy for the GVROC Region as follows:

1. Local governments should have access to funding for emergencies, and the authority on how to allocate that funding. Most often they are first on the ground and will have resources and manpower to keep the emergency situation in control. This will save the government a lot of money, the current system does not allow for that. For example: Shire of Coolgardie had a tree on fire. When contacted DFES, they were told to monitor the tree. The Shire could have easily gotten the help of residents to put it out themselves.
2. The Bush Fires Act 1954 be reviewed. Councils are responsible for Crown Land, which they do not receive rates for. It is the council's responsibility to manage any fires that start there and for our remote areas, this could mean somewhere in the middle of the bush. Councils may not have the financial means nor manpower to access some of these areas.
3. The Emergency Services Levy (ESL) should be partly allocated to local government for better fire mitigation and emergency response. For example: Two weeks ago, the Shire of Coolgardie had a fire just 3km away from town. They were unable to get any help from DFES as DFES was busy fighting fires in Norseman.
4. The DFES Superintendent should be based locally
5. Lobby the State Government to activate a Category 3 bushfire disaster recovery relief in order for councils to receive Federal funding.
6. Lobby the State Government to review its DRFA WA criteria of \$240,000. It should not be a blanket size for all councils as they differ vastly in sizes and population. It is too restrictive and does not take in other expenses incurred by shires such as social costs, accommodating stranded travellers, loss of shire and council resources to fighting fires and replacing those resources. Other states in Australia seem to have less restrictive guidelines and inclusions. For instance, some eastern states LGAs incurred road closures only during the bushfires and still received the \$1million from the Federal Government Bushfire relief funds. WA was the only bushfire state, where an LGA did not receive funding.

7. Grade the Trans Access Road and have a link road from the Eyre Highway to the Trans Access Road.
8. Great Central Highway needs funding to be improved.
9. Prescribed burnings to be changed from Environmental agencies to Emergency Services.

It is important that development of the Bushfire Mitigation Strategy considers these recommendations.

Background:

The EPBC Act requires that an independent review be undertaken at least once every ten years. The review must examine the operation of the Act and the extent to which its objects have been achieved. The last review was completed in 2009 and the Commonwealth Government announced the second independent review in October 2019.

The broad terms of reference for the review are as follows:

In accordance with section 522A of the EPBC Act, the review will examine:

- a. the operation of the Act, and
- b. the extent to which the objects of the Act have been achieved.

The review will make recommendations to modernise the EPBC Act and its operation to address current and future environmental challenges, including consideration of:

- a. The objects in section 3(1)(a)-(g) of the Act
- b. Australia's international environmental responsibilities
- c. Indigenous peoples' knowledge and role in the management of the environment and heritage
- d. implementation of relevant agreements between the Commonwealth, states and territories
- e. other legislation that may relate to the operation of the Act
- f. recommendations of previous reviews and inquiries and significant publications regarding the operation of the Act and potential reform
- g. broad consultation, including with state, territory and other levels of government, non-government organisations, Indigenous peoples, members of the community, industry and academia, and
- h. costs and benefits of recommendations.

The review will be guided by the principles of:

- a. protecting Australia's unique environment through strong, clear and focused protections
- b. making decisions simpler, including by reducing unnecessary regulatory burdens for Australians, businesses and governments
- c. supporting partnerships to deliver for the environment, supporting investment and creating new jobs
- d. improving transparency to ensure better use of information, accountability and trust in the system, and
- e. streamlining and integrating planning to support ecologically sustainable development.

The Independent Reviewer will provide a report to the Minister for the Environment within 12 months of the commencement of the review. Professor Graeme Samuel AC will conduct the review, supported by an Expert Panel comprising Mr Bruce Martin, Dr Erica Smyth AC, Dr Wendy Craik AM and Professor Andrew Macintosh.

The review will draw upon the knowledge and experience of a range of scientific and other technical bodies throughout the process including the Commonwealth Scientific and Industrial Research Organisation (CSIRO), Geoscience Australia, the six National Environmental Science Program hubs, the Threatened Species Scientific Committee and the Independent Expert Scientific Committee on Coal Seam Gas and Large Coal Mining Development. The knowledge and experience of the Indigenous Advisory Committee and Australian Heritage Council will also be sought. The review will examine a wide range of information and explore views through extensive consultation with state and territory governments, interest groups, scientists, Indigenous Australians, academics, and the general public. Over the next 12 months there will be many opportunities to be involved following the timeline below.

Oct 2019 - Review announced
 Nov 2019 - Discussion paper released
 Apr 2020 - Submissions due
 Jun 2020 - Draft report
 Oct 2020 - Final Report

The discussion paper is the first step in consultation for the review (see <https://epbcactreview.environment.gov.au/resources/discussion-paper>). With broad terms of reference, a key early step in the review process will be to identify those areas where reform will deliver the greatest benefit for the environment, business and the community, while maintaining strong environmental standards. In addition to outlining the EPBC Act, what it does and where it came from, this paper is intended to be thought-provoking. It identifies some of the long-term pressures on Australia's environment and heritage, and known concerns with the operation of the legislation, especially with its regulatory processes.

Potential areas of focus for the review are explored, and some possible options for reform are floated. These are not settled views, rather a starting point to stimulate discussion. The aim is to explore a wide range of options and to develop sensible recommendations for reform that can be implemented. Over the next 12 months the review will consider a wide range of information and explore ideas provided by communities, business, environmental groups, Indigenous Australians, academics and others.

Officer Comment:

The Commonwealth Government is calling for all interested parties to provide written submissions to the review, particularly in response to the ideas and 26 questions set out in the discussion paper with submissions on the discussion paper due by 5pm (AEDST), Friday, 14 February 2020. If the GVROC consider that the EPBC Act impacts on their current operations and their regions development, then it is suggested that the GVROC make a submission on the discussion paper.

The GVROC Executive Officer is also aware of other Western Australian groups that are preparing submissions, including the Regional Capitals Alliance WA (RCAWA). The RCAWA have advised they would be open to the GVROC working with them to develop a GVROC submission that is aligned with the RCAWA submission.

Current issues identified and to be included to date in the RCAWA submission include:

- duplication with state legislation
- precautionary principle approach
- elongated timeframes
- onerous scientific and technical content requirement
- unreasonable and unnecessary offset policies

Background:

Senator Jacqui Lambie, Senator for Tasmania, visited several local government cashless debit card trial sites this week in the Goldfields region. Senate is expected to vote on the trial's extension next month which would extend the current trial sites past 2021.

When the cashless debit card was introduced in the Goldfields, the Federal government committed to \$1 million in wrap-around services (over three years from 2018 – 2021) to ensure that children and families in the Goldfields have a well-targeted, coordinated, effective system of support services.

Discussions held between the Shire of Coolgardie and the Senator indicated that it is still unclear if the \$1 million has been invested in the Goldfields region for these services. Other topics of discussion included the CDP program, training and transition of employment for cashless debit card shopfront staff.

Officer Comment:

Senator Jackie Lambie requested that the GVROC develop a submission and include the following:

- identify priorities for the \$1M promised to the Goldfields for wrap-around services
- provide recommendations on employment options for cashless debit card shopfront staff – financial support, budgeting assistance
